DETAILED ADVERTISEMENT FOR CHARTERED ELECTRICAL SAFETY ENGINEER EXAMINATION-2024

1. Before applying, candidates are requested to ensure that they fulfil the eligibility criteria as on the last date of online application.
2. The process of Registration for CESE Exam is said to be complete only when exam fee is deposited with the Bank through GRAS (Government Receipt Accounting System) Online mode on or before the last date (18th March 2024) for payment of fee.
3. Candidates are advised to visit Department's website <https://www.ceimah.in/> for further details and updates, if any. No separate intimation will be issued in case of any change/ update. All changes/ updates/ corrigendum will be hosted on department website only.

As per Notification published by Government of Maharashtra:- Misc 2019/C.R. 96/ Energy-5 Dt.20th September, 2019, the Chief Electrical Inspector, The Industries, **Energy** & Labour Department, Government of Maharashtra is inviting application from suitable candidates, possessing necessary qualifications and experience as prescribed in Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2023, Regulation No.6 for **Chartered Electrical Safety Engineer (CESE) Examination 2024**.

➤ **The schedule of Examination is as follows:**

Payment of Examination Fee	28 th February 2024 to 18 th March 2024
Download of Admit Cards	24 th March 2024 onwards
Chartered Electrical Safety Engineer (CESE) Examination	29th March 2024

➤ **EXAMINATION PATTERN :**

- a) Examination will be conducted online and will consist of 100 Multiple Choice Questions (MCQ) for 100 marks.
- b) The total duration for the examination will be 90 (Ninety) Minutes.
- c) It is necessary for candidates to be well conversant with all the subject/topics/contents as mentioned in the syllabus. (Link for the syllabus mentioned below)
- d) Those candidates who secured 50% marks, will be declared as Pass/ Successful.

➤ **EXAMINATION CENTERS:**

- a) The examinations will be conducted online at Mumbai, Pune, Nagpur and Aurangabad.
- b) No request for change of examination centre will be entertained.
- c) This Department reserves the right to cancel any of the Examination Centres and/ or add some other Centres, at its discretion, depending upon the response, administrative feasibility, etc.
- d) Candidate will appear for the examination at an examination centre at his/ her/ their own risk and expenses and this department will not be responsible for any injury or losses etc. of any nature.
- e) Any unruly behaviour/ misbehaviour in the examination hall may result in cancellation of candidature/ disqualification from future exams.

➤ **ADMIT CARD:**

- a) Admit Card will be available for download from 24th March 2024 onwards.
- b) Admit Card of exam will not be collected at the examination venue. However, it will be duly checked/ authenticated/ stamped by the exam centre staff. Candidate will need to retain the admit card along with authenticated copy of ID proof.

➤ **HOW TO APPLY :**

- a) Before applying the application form candidate has to register himself/herself. For registration, the candidate must have a valid Email ID and mobile number.
- b) Then for registration on portal [Click here](#). You will be redirected to the “Register Yourself” icon in the portal. Enter all the required information and validate it. The

system will send one email OTP and mobile OTP to your respective email ID and mobile number. Enter the email OTP and mobile OTP received by you and submit. Once it is successful your login account is created.

- c) Go to the above link and login to your account.
- d) Fill up the details as per the requirement of the online application.
- e) Make the payment.(₹.3000/-)
 - 1. Make the payment through Website, [Click here](#).
 - 2. Go to the website and select "Pay without Registration" and Enter "Chief Electrical Inspector" in Department Name and click on Submit.
 - 3. Select "Other Receipts " in" Payment Type", Select District "MUMBAI" then select "SECRETARY LICENSE BOARD,CHEMBUR MUM" in "Office name"
 - 4. Select "'Examination Fees of Licensing Board" under "scheme Name"
 - 5. Select "Period Year" as "2024-25" and "One Time /Adhoc" in adjacent Tab.
 - 6. Enter amount of 3000 in Amount tab.
 - 7. Fill Payer details.
 - 8. Add "Fees for the CESE Online Examination 2024" in "Remarks" Select the payment Mode and Make the Payment.
 - 9. Print and keep the challan copy for application Process.
- f) Upload photo and signature as per prescribed size along with other documents.
- g) After filling up the details in the online application form and ensuring that information has been filled up as per the requirement of the application, submit the application by using the "Submit" button.
- h) The following documents need to be uploaded with the application. Ensure that the required documents are scanned and kept ready for uploading before filling up the application :
 - a) Work Experience Document
 - b) Date Of Birth proof document (leaving certificate, birth certificate etc)
 - c) Academic (Diploma/Degree in Electrical Engineering) proof document
 - d) GRAS Payment Receipt
 - e) Domicile Certificate

- i) After submitting the duly filled application, the system will send confirmation email and SMS to your respective email ID and Mobile Number.
